2009 FAMILY APPLICATION & CONTRACT**

Provision:

Swimmers who are new to DCC Swim Team may take advantage of a 1 week trial period. This offer is limited to new swimmers only. This provision does not provide 1 week free to swimmers who stay on the team. This allows swimmers and divers to tryout and receive their money back if they decide not to stay on the team. This 1 week trial starts from the date of the contract. You must notify DCC Head Coach by the end of the 1 week period in order to receive a refund.

Registration Fee:

Each application must be accompanied by the summer program fee of \$45 which is used to pay conference dues, buy award ribbons, meet entry fees, pay for coaches. DCC will travel to 2 Away meet and host 4 home meets.

Work Requirements:

Each family member is expected to fulfill a minimum work requirement of 3 swim meets attended by Danville Country Club Swim Team. For the summer team meets you will indicate what meets you are available to work. After the initial sign-in, job assignments will be made by a meet committee to ensure all positions are filled. You will be charged a \$50 fine for each meet you do not work. If you prefer, you may pay a \$150 fee to 'opt out' of this obligation. Any family working more than 3 sessions will be credited \$30 per meet. **If something comes up that you cannot attend the meet it is YOUR responsibility to switch with someone who can.** Each family is required to work 3 meets.

It is hereby acknowledged and agreed by the undersigned that in consideration of your child (children), listed herein, being accepted as a member of Danville Country Club Swim Team you agree and understand the above obligations are included as part of your entire commitment during the time period from 5/25/09 through 7/15/2009.
